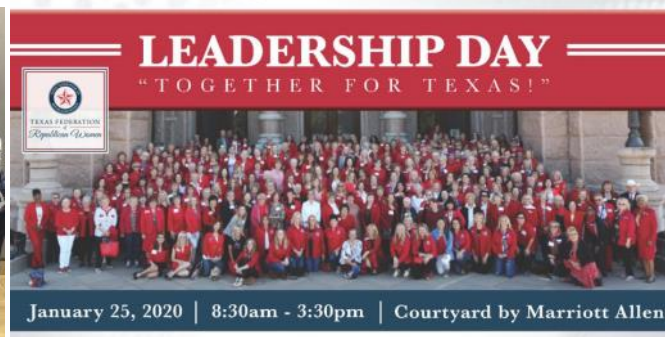
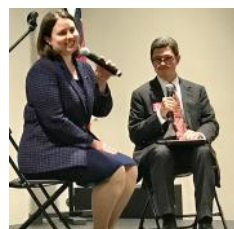

## Courageous Faith: Stepping Stones Church

Tucked away in a sleepy little part of the McKinney ETJ is a new church where big things are happening. Stepping Stones Church sits on 36 acres of farmland, making it the perfect place for some of the church's outdoor activities like horse riding, skeet shooting, and BBQ's. The casualness of the surrounding scenery continues inside to the sanctuary, where on any given Sunday morning you'll find folks sipping coffee while their articulate and funny leader, Pastor Jeff Nyberg, PhD, takes them through scripture. Though self-effacing, it quickly becomes clear to newcomers what the congregation already knows, Dr. Nyberg is no ordinary pastor. Free from the confines of political correctness, Pastor Nyberg delivers refreshingly frank and intelligent sermons that shine the light on social issues which are running afoul of Christian values and afflicting our country—the very message we've been asking churches to deliver.

My discovery of Stepping Stones Church began several weeks ago while sorting through the usual pile of mail the postal carrier brings each day. Like many, I barely glance at unsolicited items before dropping them in the trash. On this particular day, I was in the process of tossing out one flyer when something on it caught my eye and I froze. I couldn't believe what I was seeing: a message from a church about godless policies our country is facing and the need for courageous faith. A provocative message from a church? Amazing. I had to see this for myself.



The following Sunday, my husband and I attended Stepping Stones Church. Just as the flyer said, Pastor Nyberg talked about specific issues and the urgent need for Christians to wake up.

I left church that morning inspired by what I had witnessed. I couldn't help but wonder, though, whether it was an isolated occurrence. Was the good pastor going to move on to safer, less controversial subjects? Fascinated by the possibility that we might have stumbled into something new, my husband and I attended a few more services. On each occasion, without fail, Pastor Nyberg addressed hot topics that are relevant to Christianity but that churches typically avoid.

With studies showing only a small percentage of eligible Christians are actually voting, we need more churches like Stepping Stones. We need churches that are willing to tackle difficult issues and motivate Christians to vote their values. Don't get me wrong, Pastor Nyberg is not attempting to influence legislation or campaigns. Stepping Stones is not engaging in political activities. Pastor Nyberg's sermons are entirely focused on the Bible and spreading the Word of God. Pastor Nyberg, however, is not afraid to point out existing and developing social issues that are contrary to Christian principles.

I hope you will reach out to Pastor Nyberg and let him know, as I have, that you appreciate his good work and want it to continue. Cheer on Pastor Nyberg and his flock by attending one of the Stepping Stones services, telling others about the church, making a donation, sending a thank-you note, liking the church's Facebook page (especially considering Facebook censored one of their posts), and anything else you can think of to help grow the Stepping Stones momentum.

### Texas House Redistricting Committee Hearing

Lots of great testimony at yesterday's Texas House Redistricting Committee Hearing at Collin College. My comments were focused on ensuring that Committee Members, as well as the Legislature as a whole, remain directly involved in the process. We are a Constitutional Representative Republic, and therefore, we elect our representatives to do this work. I was very concerned when I heard suggestions that an independent board should be appointed, because that board would not be accountable to the people. Rule of Law and Accountability are paramount. We don't need unelected and unaccountable bureaucrats making decisions for the future of Texas. The Legislature's job is to follow the law... to be fair, accurate, and follow the requirements of the Voting Rights Act. With population changes, it is a given Texas will gain Congressional seats, and State House and Senate seats will certainly need adjustments. However, the harder task will be deciding what is best for the state of Texas, not individual districts or members. Finally, please be sure you are part of the complete count numbers in the Census. So much rides on this, including transportation, representation and federal grants.



A North Texas local official is suing a federal bureaucracy for stifling faith-based free speech.

Susan Fletcher, a graphic designer from Frisco who also serves as Collin County's Precinct 1 commissioner, is challenging a United States Postal Service regulation that prevented her from expressing her faith on custom-designed postage stamps. Fletcher's [lawsuit](#) argues the federal restriction is an unconstitutional violation of her rights guaranteed by the First Amendment.

Fletcher wanted to create personalized stamps for Christmas and Texas Independence Day that communicated a Christian message to family and friends, using a government-approved third-party vendor.

But she discovered that a USPS regulation prohibits custom stamp designs that contain any depiction of religious content, which it categorizes as "unsuitable for all-ages audiences" along with political, violent, and sexual content.

"I just want to express my faith in everything I do, at Christmas and all throughout the year," Fletcher said in a [press statement](#). "I am truly saddened that the country I love would keep me from expressing the most important message I could share with others: my faith."

"This regulation by the USPS not only chills speech, it silences it," said Jeremy Dys, special counsel for First Liberty Institute, which filed the federal suit on Fletcher's behalf on December 19. According to Fletcher's [complaint](#):

The Supreme Court has repeatedly held that this kind of categorical exclusion of religious perspectives on permitted topics constitutes impermissible viewpoint discrimination in violation of the First Amendment's free speech guarantee. It also creates a substantial burden on Ms. Fletcher's religious practices in violation of the United States Constitution.

"Personalized postage stamps do not violate the First Amendment just because they reference religion," said Chad Walker, a partner with Winston & Strawn who filed the complaint along with First Liberty. "Government regulations prohibiting religious speech by Americans offend the First Amendment."



## The Many Benefits of Block Walking

Ask any seasoned campaign manager and they will tell you a key component of winning any election is block walking. Studies repeatedly show that block walking – or canvassing - is the most effective form of campaigning, and that means if you are volunteering to block walk for a candidate, you are a crucial part of their victory! Here are just a few reasons why:

### Block Walking Increases Overall Voter Education and Awareness

- Education is the backbone of a grassroots campaign. Why? Because people cannot vote for what they do not understand. Door to door campaigning increases their awareness of both the candidates and the issues because candidates have the opportunity to communicate directly with their voters. Also, higher levels of visibility gain more support because it builds voter confidence in a candidate.

### Handing Out Literature Increases Voter Support

- Giving candidate literature – like push cards – directly to the voters helps to educate them on the issues and boosts the candidate’s visibility and name ID. Let’s say one block walker hits 100 doors a day, leaving a push card at every door. On average, that walker will also have 25 conversations a day with those voters. That means in just one day, that one walker increased the candidate’s visibility and name ID with at least 100 voters, having face to face conversations with 25% of them. Some smaller races are won by only a few hundred votes. Think of the impact just one walker and their trusty push cards could have.

### Conversations with Voters Benefit Both Candidates and the Local Party

- The average voter is like any other person face-to-face interaction is the best way to build a rapport with them. Block walking allows both candidates and their volunteers – who are their advocates – to build a rapport with their supporters and potential supporters. Those interactions also help your local party collecting voter data through questions such as “Do you vote regularly?”, “Do you prefer to vote straight ticket?”, “Are you happy with how you’re being represented?” This data helps your local party understand the voting trends and preferences of their local voters, which in turn, will help your candidates be as effective as possible in their campaign messaging and voter targeting. It’s a win-win!

### Block Walking Benefits the Voters, Too

- We’ve covered the many ways block walking benefits candidates and your local party, but it’s equally important to realize that it benefits the voters, as well. The average voter is like anyone else – busy! Busy making a living, raising children, etc. Those in-person interactions allow voters to put faces with the many names on their ballot they might not have had time to research. Those interactions also give voters the chance to discuss the issues that are important to them, giving both the candidate and the local party a better knowledge of what real folks care about. Lastly, this face-to-face interaction gives voters a lasting memory – and hopefully a positive one – to take with them to the ballot box, having confidence in the vote they’re about to cast.

# The Many Benefits of Block Walking (Cont)

**Now that you've had a snapshot of the many benefits of block walking, let's move on to some basic guidelines on how to do it successfully.**

- "Density" = quantity of voters/potential voters you want to target
- In determining where block walking will be most effective, look for voter density then determine which precincts should be walked first.
- On average, you will approach 15 doors an hour, and you can assume there are two registered voters per house.
- Don't knock in apartment complexes, and be sure to include them when determining the voter density of an area.
- You will learn to speak effectively through trial and error. Don't worry! You will get the hang of it after only a couple of doors!
- Overall, Seniors are home all day and tend to vote conservative.
- Do not debate with voters! You are there to educate – not argue – and it will leave a bad impression of your candidate with the voter.
- If voter disagrees with you, speak on the candidate's side of the issue politely then move on quickly. Efficiency is key – do not waste time trying to convert the opposition. Leave a push card if appropriate and return at later date for persuasion if your candidate would like you to.
- Do not lie! It is OK to say you are not sure or you do not know.
- Most questions are either on important issues to the voter or current news so try to pay attention to current events when preparing to block walk.
- Daily block walking increases a candidate or party's ability to analyze SWOT – Strengths, Weakness, Opportunities, and Threats – so any interaction is a valuable interaction! Don't be discouraged!
- Remember, voters appreciate personality and the ability to relate so relax and enjoy the chance to visit with them.

## **General Tips for Approaching a Voter's Home**

- Educate yourself on current events so you have context for what might be important to the voter.
- Knock or ring the door bell then step back 1-2 steps so you do not seem aggressive or threatening.
- Politely introduce yourself.
- Hand the voter a push card only after introducing yourself.
- Speak clearly and slowly enough for them to understand.
- Pay attention to body language and mimic it so the voter can feel relaxed then speak accordingly. If they are in a hurry, keep your introduction short, hand them a push card, and leave them to carry on with what they were doing.
- Be aware of surroundings like the day of the week, time, neighborhood, dogs, etc.
- Really listen to the voter and create dialogue when possible.
- Leave a positive impression that the voter can take to the ballot box regardless of their views.

Now that you understand the hows and whys of block walking, you should feel confident and empowered in the role that you as just one volunteer can play. You are an invaluable part of helping your local candidates and party engage voters, win elections, and make positive changes for everyone, yourself included.

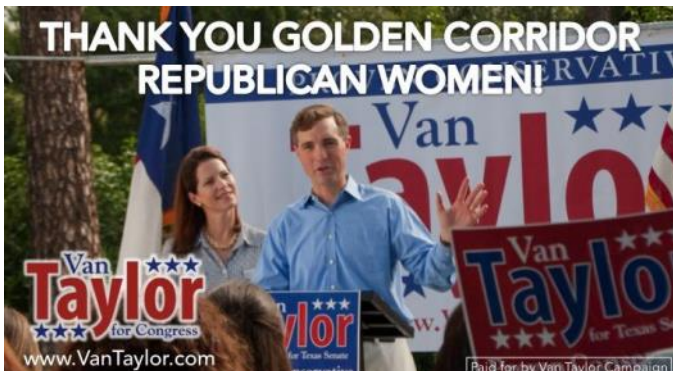
