Grateful for Justice.

If you were at our October meeting, you know that our scheduled speaker Justice Don Willett had to cancel at the last minute, after President Trump nominated him to the U.S. Court of Appeals for the Fifth Circuit. For a lot of reasons, the nominees are asked to immediately cancel all speaking engagements and focus on the new task at hand.

Our disappointment at losing Justice Willett as our October speaker was quickly replaced by our excitement at the prospect of adding a mega-talented, conservative justice to the Fifth Circuit. And, we were grateful when Justice Willett recruited another Texas Supreme Court justice, Justice Jeff Brown, to speak at our meeting—if we were interested. Of course, we were interested! Justice Brown was a superb choice. He showed up with Texas Supreme Court Justice John Divine (it just kept getting better!) and gave an outstanding presentation on “Conservative Judges and the Constitution.” Afterwards, guests surrounded Justice Brown asking if it was possible to get a copy of his speech. It was that good.

We are blessed to have so many great justices on the Texas Supreme Court and in our Dallas Court of Appeals. Please don't take them—or our excellent county and state court judges—for granted. Do what you can to support them in their campaigns this year and next, and make it your goal to keep Texas strong by getting as many people as you can to the polls in November 2018 to vote our conservative judges, justices, and other great candidates.

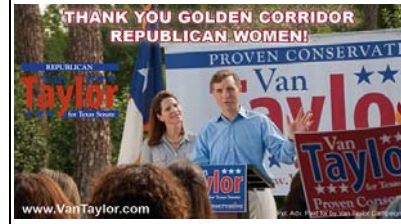

Highlights for some members were:


- During the Memorial Prayer Breakfast, GCRW's Chris Davis read the list of members who have passed away during the last two years from all clubs across the state. U.S. Representative Louie Gohmert spoke about his time as a judge and now in Washington, ending with the plan of salvation and why our nation must hold onto our religious rights. State Comptroller Glenn Hegar sponsored the breakfast on another morning.
- Cute, obedient Patriot Paws service dogs protected their handlers. Lieutenant Governor Dan Patrick pledged to raise an additional \$30,000 to provide training for another dog. This has been a project for GCRW as well as TFRW.

GCRW members have been participating in **National Life Chain** since it first came to the Dallas area in 1990. This year again on the first Sunday of October, they were part prayer events in 1550 cities and towns – many with multiple locations so that 1840 locations were listed on www.LifeChain.net.

At the Plano location, long-time GCRW member, Angela Paxton, shared her story about being adopted and how important she believes it is to stand up for life. Every year coordinators report stories of babies whose lives have been saved when their mothers and fathers see people praying and understand the messages on the signs that are provided at each site.

When **40 Days for Life** founders realized that closing abortion clinics would take lots of prayer, they began a ministry that also is now held in other nations.

On October 24, GCRW members prayed in front of Southwestern Women’s Surgical Center in Dallas where thousands of people passed and had an opportunity to read positive signs which are also used at Life Chains, such as “Adoption – the Loving Option,” “Pregnant? Need Help? 1-800-712-HELP.”


Through the years the lives of more than 13,000 babies have been saved as result of God using the public witness of ordinary people praying silently.
